#### **Terms & Conditions**

- 1. By completing and signing this form, you the Stallholder agree to attend both days of the two-day markets. Failure to attend both days will result in a breach of this agreement and will jeopardise future applications for the Gladstone Harbour Festival Two Day Markets.
- 2. Copy of your public liability policy (i.e. Certificate of Currency), covering event dates to be attached to the application form.
- 3. Stalls can only be set up from 6am on day/s of market and completed by 8.00am. All stalls must cease trading at 4pm and be packed up by 5pm on Friday 18<sup>th</sup> & Saturday 19<sup>th</sup> April (NOT PRIOR). **Your site must be left in a clean and tidy state free of rubbish.**

NO sites are allocated prior to Good Friday – you will receive your site position on arrival. Event Coordinators will email you prior to the event with general bump in information.

- 4. There is no power available to market stalls at this site.
- 5. Insurance for loss, damage and public liability is the responsibility of the stallholder. The Gladstone Festivals & Events Association Inc. (referred to as GF&E) will not be responsible for any loss or damage incurred by stalls or contents, or for damage caused by stallholders, their equipment, or vehicles, to property owned by either stallholders or contractors.
- 6. The GF&E reserves the right to expel any stallholder and requires such stallholder to be removed should the conduct of the stallholder be in any way detrimental to the well-being of the Festival or should the products/services be other than those stated in this agreement. In the case of such expulsion, monies paid to the GF&E will not be refundable.
- 7. Your site payment is due at latest on the 7<sup>th</sup> March 2025. **GF&E reserves the right to charge cancellation fees**. Please refer to these further on page 2.
- 8. We will send you an application form as soon as they are prepared for next year's festival but if you change your contact details or they are hard to read, it may result in your not receiving this form. Email addresses are our preferred method of correspondence.



- No fast food or soft drinks to be sold
- Stallholders must stay within their allocated site when selling products to the general public no roaming sales
- No Explicit and hardcore t-shirts, Fake cigarettes, Fuel type lighters (zippo), Knives (including pen knives), Metal
  and wooden martial art nunchakus, Playing cards (nude or lurid), Drug related goods (including paraphernalia bongs, cocaine kits, etc), Fireworks and crackers, Laser pointers, Swastikas, Stink bombs, Pressure pack fart gas,
  Shanqhai's
- Toy guns, except for the following, are acceptable: Pellet guns, Ball bearing guns, Replica guns, Popo downs (throwdowns), Spud guns, Roll caps, Strip caps, Eight shot caps
- Sites must not exceed 5m depth
- No overnight camping is allowed
- No security is provided for stalls left overnight
- Check all information is provided on application form for acceptance
